OFFICER'S REPORTS

President-Steve Daidone - Steve apologized to the members for not attending the meeting last month due to the birth of his new grandchildren. Steve became a grandfather of 3 in one month. Congratulations to Steve and his family!

OPENING COMMENTS FOR CURRENT BUSINESS

He reminded the group that flyers for upcoming shows and the event calendar are available at the BOD table.

Steve also reviewed the possibility of sending out the monthly minutes via email. He took questions on interest and feasibility. More to follow.

Thanks to John and Mary for their efforts to bring and set up refreshments for each meeting. However, they have decided to officially resign from this assignment at the end of the year. Steve asked for any volunteers to perform this assignment starting in the new year.

Thanks to Rich Fingerhut for his continual work in gathering information and updating the LIV website.

Although Mike reviewed many of the issues below in detail, in Steve's absence, at the last meeting they will be restated for the purposes of these minutes. Steve had elected to re review them and added a few more current items. Mike also added comments to support Steve's concerns.

- 1) Steve mentioned that we could have a club event at the Malibu Beach Club in Lido Beach in May/2017 that could be a low-cost show and good opportunity for the club to generate additional funds. It was also mentioned that a photo shoot could also be included to create interest for club members and non-members, as well. More details and discussion to follow.
- 2) Steve and Mike also informed the group that The Last Hope Animal Rescue and Rehabilitation would be having their 35th annual dinner on October 27th at the Coral House in Baldwin. This year they will be honoring Joe Greco, our LIV member, for his past efforts and contributions in support of the Last Hope organization. The cost will be \$80 per person and anyone who is interested should inform the BOD by October 12th. Approximately 15 members expressed their potential interest to attend.
- 3) Steve and Mike reviewed the club's participation in the Corvettes at Carlisle event in Pennsylvania. Although members still desire to attend this event, it was agreed that there were less cars, less vendor participation and overall appeared to be a quiet showing of people. There was an open discussion where the members agreed to renew the existing spots and possibly add additional spots next year. Steve took this request under advisement for next year's participation at the show.
- 4) LIV Picnic - it was discussed that there was a low turnout and it appears that this event was losing support.
- 5) Riverhead Raceway event - during previous meetings, it appeared that this event had interest; however, in actuality, on the day of the event, it had a poor turnout and support. A suggestion was made to pay in advance thereby

- guaranteeing attendance. More discussion required.
- 6) Steve and Mike discussed that the Mangano show and asked the members for feedback. There was a low LIV turnout (approximately 6 cars) probably due to rain in the early hours. But as the day progressed, approximately 150 cars participated in the show. An open discussion followed. LICOA had 35 cars, Corvette Society had 15 cars.
 - 7) Steve suggested that maybe we should have interclub reciprocity at events to show support for fellow clubs. A good example would be for LIV members to attend the LICOA Huntington Show on October 23rd.
 - 8) Mark Tully informed the group that the North Fork Wine Cruise event at Laurel Lakes would be held on November 6th and requested that this event be published and promoted in the monthly club newsletter. Steve stated that he would honor this request. Mark informed the members there would be a combined donation from LIV, NCRS and LICOA of \$4000 given to the Stony Brook Veteran group. Mark also mentioned that we would caravan to the winery starting from the new rest area on the LIE exit 65/66 at 11:15am.
 - 9) Steve reviewed the planning process for the 2017 Valentine's Day Brunch. It will cost \$40 for guests and the members will be free. This event would require a 25/30-person guarantee and will be held on the 19th of February.
 - 10) There was an open discussion concerning the possibility of the creation of a legalized drag strip on Long Island. Steve is a member of the association that is considering the development of this possibility.
 - 11) Mike discussed possible ways to improve the LIV BFCU show. An open discussion followed.

Treasurer - Tony Sorrentino - Tony reviewed the current financial status for the month of September period. The opening September 1st balance was \$12,059. Cash deposits from membership fees, 50/50, and petty cash less current monthly expenses brought the new monthly ending balance to \$10,330.

Membership Secretary - Louis Trohatos announced that the current membership for the club is at 79 members for this month. Joe Morabito was introduced as a new member. He has a 2008 corvette. The following birthdays were announced:

Lou also informed the membership that he is handling the renewal of one of the club's two trademarks, "LIV the Dream," which is due to expire on

October 19, 2016 (the other trademark, "Long Island Vettes," has until July

17, 2018). He stated that Art Donnelly had communicated with the Board

regarding the renewal process and the option of using a specialized law firm to make the filings (renewals are required between years 5-6 and years 9-10 to show continued active use). Lou stated that there will be a \$395 cost to renew (\$100 filing fee for the United States Patent and Trademark Office, and \$295 to Lee, Lee & Associates, the trademark law firm we've hired to make the necessary filing. The membership agreed to this process.

General Secretary - Tony Savino - the reading of the minutes for the September meeting was waived.
