Open Discussion

1. It was suggested that we move the Vanderbilt show to late July/early August where there is no competition from other shows. This could be the answer to the last few years of low turnout.
2. Various ideas to save money were discussed:
 - a) Eliminate entrants' choice, or limit the number of trophies, e.g., to 3.
 - b) Eliminate Best of Division trophies.
3. It was suggested that Best of Show not be awarded by judging, but by joint decision of the President, Vice President, and Judging Chairman. This might avoid some Best of Show winner controversies.
4. It was suggested that raffles should always have a 50/50 component, as they've always had in the past at our shows, and expected by attendees.
