Tony Sorrentino and Rich Larsen who transported everything we needed from the storage unit to the storage pods at FourLeaf for our show.

Mark Feldman for helping to get vendors. The simulator vendor that he got was busy all day!

Tom Scanapieco who brought bagels and cream cheese already prepped.

Joe Cook who brought coffee – the fuel that got us all going so early in the morning.

Judging Chairman Joe Balabanick, who handled the classification and final tally of all the awards.

Deb Cook and Marie Alberto for walking around the field all day selling 50/50 tickets.

Joanne Sorrentino, Sandy Puccio, Deb Cook and Marie Alberto for selling club merchandise.

The Registration Team - Al Roscoe, Mark Tulley, Pete Puccio, Doug Brooks and all the others who helped with that and then helped with parking.

The Parking team who got everyone parked together.

All the members who did the judging in the heat on the hot asphalt. It is a challenging job, with over 135 cars judged!

After John's comments, Rich F. raised his hand to acknowledge John A., who had also worked extremely hard on the show to make it successful. It is not an easy task!

News 12 came to the show. They filmed the field with all the cars and interviewed Cathy Balabanick, who was there at the booth for Last Hope Animal Rescue and Rehabilitation. Last Hope did well with their fundraising. They raised \$1,050.00 from the vendor fees from our club. They received a donation of \$1,000.00 from Vincent Doto who is with Empire Muscle Cars. They also had items to auction at their booth and raised money from that.

The vendors seemed to be very happy with their sales. This year we positioned the food vendors along the back fence, where their generators did not bother anyone at the show. The Greek food vendor wants to definitely return next year.

It was nice to have the music and announcements positioned along the ATM driveway and closer to the electric outlet, but some of the neighbors in the apartments behind the bank would like it to start later. The judging sheets and the large number for each car needs to be positioned prominently on the window so the judges can easily see who needs to be judged. Some cars were admitted after judging closed but did not care that they could not be judged. However, they still need to sign the liability waiver upon entry to protect the club. This year no one was upset that they did not win a trophy after being told "you'll definitely win a trophy because there are no other cars in your class."

All in all, it was a very good show this year even though it started out with rain and drizzle in the early morning. Things got started a little late because of the rain, but it may be that because some of the other shows were canceled due to the early weather, we were the recipient of those cars.

Elections of LIV Officers

This year we need to hold elections, which occurs every two years. Any member can run for any office if they have been in the club for a year (12 months), have attended at least four events, and paid their dues. Nominations will be held in September. The Membership Secretary will then contact those nominated to see if they will accept the nomination. Elections will be held in November. The new Board will assume their responsibilities in January. All offices are open for election, though Brian Larsen and Marty Baker-Fingerhut are willing to stay in their positions if no one else wants to run. John A. encouraged all members to consider holding an office on the Board.

Holding Elected Positions on Two Boards

LIV has had a rule that no elected LIV member can hold an elected position on another car club Board. This had been ruled in the past when there was the possibility that certain members of another club would attempt to be elected and disrupt our club. That is not the case any longer. This rule might limit our present possible officers. Marty Baker-Fingerhut has been appointed to Membership Secretary of the Metro-Long Island Chapter of the NCRS as they are without an active member in that position. This is an appointed position in NCRS so technically there is no conflict. Rich Fingerhut has been appointed to finish out the elected term of Vice-Chairman of the Metro – Long Island Chapter of the NCRS as that position is held by a member who is unable to attend many events due to geographical distance but has held the position to have it filled. His position (Webmaster) on our Board is an appointed position so technically that is not a conflict. However, both Marty and Rich want to be certain that this does not present an issue for our members. A discussion ensued and it was decided that this should be determined on a case-by-case basis. In both of these cases, there was no voiced opposition to these members assuming the positions in the other organization as they are deemed responsible enough to handle both positions. For other members that may not be the case.
